ALLIED

Only an association, coalition, chamber of commerce, or other similar alliance and organisation, whose principal business is representing member companies and industries impacted by counterfeiting, and/or promote fair trade, economic growth and pro-business regulation, anywhere in the world shall be eligible to be an Allied Member applicant.
